**Dated Aizawl, the 21<sup>st</sup> March, 2020**

**ORDER**

In continuation to this office Order No. PHQ/IGP(L&O)/73/COVID-19/2020/1094 Dt. 20.03.2020 in respect of preventive measures being adopted by the State Government to prevent the spread of Coronavirus into Mizoram, the State Government have decided to lockdown the State of Mizoram for a period from 22<sup>nd</sup> March, 2020 to 29<sup>th</sup> March, 2020 as stringent measure for possible entry of the virus to the State.

In addition to this, prohibitory order under Section 144 Cr.PC have already been promulgated today i.e 21.03.2020 and this will be enforced at least upto 10<sup>th</sup> April, 2020 to check possible spread of Coronavirus. All District SsP have to ensure effective implementation of the order for the larger interest of the public.

1. Therefore, it is hereby instructed that all District SsP to make elaborate Law & Order arrangement for implementation of the Government Order/Notification as above under close supervision of concerned DIG of Ranges.

2. During the period of lockdown from 22.03.2020 to 29.03.2020, all business/shops are to be closed except essential commodities and vehicular movement will not be allowed except for person exempted. However, office will remain open on working days and vehicle used by officials for attending office are also exempted. Details of exempted personnel are as follows:-


3. In Aizawl, SP Aizawl and SP Traffic will make arrangement so that Police and Traffic personnel are jointly on duty at important traffic junction from Sikulpuikawn to Bawngkawn including Company Peng and Vaivakawn to effectively check unauthorized movement of any person and vehicles. SP Aizawl may make requisition of Gazetted Officers for Zonal Officer to assist him in Aizawl for the entire period as may be required for effective implementation of the arrangement.



4. SP CID(SB) Mizoram is requested to kindly gear up his field staff for hard intelligence that might have come out of the Coronavirus.

DIG(NR), (ER) and (SR) will closely supervise the entire arrangement in all Districts and monitor the situation closely and update DGP, IGP(L&O) and IGP(Intel) at 8:00 AM and 4:00 PM daily with any notable events during the period.
